

Where We Are Located

Somerville is located on the Mornington Peninsula, 55km southeast from Melbourne, Victoria and is viewed as part of Metropolitan Greater Melbourne. The Mornington Peninsula Shire Council (MPS) is the local government with Somerville located in the Watson Ward. According to the 2016 Census the population was 11,336 (ABS, 2021).

The Somerville Community House Incorporated is an independent not for profit organisation governed by a volunteer Committee of Management and is a member of the Neighborhood House Network. It is supported by Neighbourhood House Victoria and the Community House Network Southern Region associations. Annual funding is provided by the Victorian Department of Families, Fairness & Housing (DFFH) and the local Mornington Peninsula Shire Council (MPS) who also provides and maintains the building. Additional funding sought generally relates to specific projects or programs.

The Somerville Community House Incorporated is situated in the purpose-built Annie Sage Community Centre in the same precinct as the newly renamed Tillerkite Preschool, Beek Beek Reserve, and includes the Somerville Senior Citizens hall. Blacks Camp Road was recently changed to Worwong Avenue due to the MPS Reconciliation Action plan and discussions with First Nations people.

The Annie Sage Community Centre is shared with the Department of Child and Family Health also known as Maternal and Child Health who provide an essential service for families, host a first-time parents' group and monthly childhood immunisations. The Somerville/Tyabb Rotary group meet here every Wednesday evening.

Strategic Goals for 2020-2024

1	Increase the level of community participation.	Our participation rates continue to steadily increase by 11% each term and our music groups are proving very popular with more than 60 people enrolled in our Bluegrass group. However, the pandemic has left it's mark on people's confidence to mix and continues to affect our attendance rates. Another challenge is finding and retaining volunteers and suitable tutors to facilitate some of our classes. We are however optimistic of improved community confidence and outcomes as we go forward.
2	Partner with other community organisations, businesses, government & philanthropic organisations to secure appropriate funding and support.	This year we received additional funding from the Federal Government due to Covid restrictions and the Mornington Peninsula Shire increasing our annual funding to \$20,000. We were also fortunate to receive a grant, with support from Greg Hunt, Minister for Health, from the Federal Government for \$10,000 to plant trees for the Queen's Platinum Jubilee in our backyard. A grant of \$1636 from the Department of Justice for Air Purifiers. We signed up to the NHVic & Brotherhood of St Laurence initiative to support the State Government's Power Bonus scheme and we recently collaborated with the Tillerkite Preschool to promote all of our Centre's & celebrate the street, reserve and preschool's name change.
3	Identify community needs and aspirations though an annual Community Consultation in conjunction with the Mornington Peninsula Shire as well as in our house.	In order to support our older community and to reduce loneliness, we met with the Somerville Senior's group to provide our support. We now include the Senior's activities in our Program and hold our popular Bluegrass & Singing Group sessions in the Hall. The Seniors have preferred to maintain their club's status quo for now, so we currently share the space. The Hastings Seniors are currently using the Hall once a week for their Bingo as they await repairs to their hall. We continue to collaborate with the Somerville/Tyabb Rotary project to 'Beautify Somerville' and have provided funding via the MPS to rebuild the Community Signage board located in the centre of Somerville.
4	Determine appropriate community programs, activities and services in response to needs identified, ensuring that diversity and differences are valued, especially in line with the Shire's Health and Well-being Plan.	We have a wide selection of low-cost classes in response to discussions with participants who value these affordable opportunities. This has led to more visits from those receiving NDIS funding. The Bluegrass group has expanded our reach so we now have more men visiting our Centre and engaging in activities. The Bluegrass group has led to more musicians attending monthly performances, a weekly Ukulele class and a fortnightly mixed singing group. We introduced a monthly florist workshop, photography group and a writer's group but the latter classes have paused due to health challenges & the difficulty of sourcing available group leaders. We have introduced a Mah Jong and a 500 card game group as requested & continue to monitor our activities to promote variety.

Strategic Goals for 2020-2024 continued

5	Establish a member governance base to diversify and support the Committee of Management.	The monthly MPS Governance Meetings are missed but The Committee continues to work closely with the Manager, the CHN, NHVic and the MPS to keep up to date with the everchanging landscape and ensure compliance on all levels. Our volunteers have become members of our governance base and are invited to attend our AGM. The recruitment of new and effective Committee members is ongoing.
6	Evaluate the effectiveness of all aspects of Somerville Community House operations including programs, practice, governance and delivery of quality program/activities and services.	We provide a variety of ways to evaluate what our community deems effective and respond to that need. Our participants often tell us how important visits to the Somerville Community House is to their wellbeing and their sense of community. We distribute evaluations and collect responses to events by encouraging participants to write us messages. We also have a Positive Feedback and Complaints policy in place that has been recently reviewed. Now more than ever people are keen to engage with their local community and connect with others. However, we continue to see a rise and fall in attendances due to impacts from recent bouts of family illness, low immunity or more demands on care providers.

Annual Report from the Chair 2022

The on again off again in the latter half of 2021 made running of Somerville Community House challenging for our Manager Kim Fitcher and made it a worrying time for everybody. Our long standing, Secretary Rhonda Fincham stood down from the position after many years for which we thank her tremendously. Rhonda is not 'lost' to the Committee and has taken on the mammoth task of writing the history of SCH. Lynda Tredwell took over as Secretary and has been doing a great job. We also had to accept the resignation of Rob Clarke from the Committee and thank him for all his work and wish him well with his health and other commitments. We were pleased to have Richard Booth join the Committee during the year, the more varied the ideas and discussions, the better for all. We, like many organisations, 'lost' many of our volunteers during the lockdowns but now have an ever increasing 'band' of people wishing to "give back to the community". Without volunteers we could not function, so many thanks to them from the Committee.



Our Committee held online zoom meetings during the lockdowns and met face to face when we could in a safe manner. We purchased Hepa Air Filters for the Centre to ensure a safer environment within the House, while the sound proofing and privacy curtains in our main meeting room have been a great success.

Unfortunately, most of our planned meetings with the Shire, Senior Citizens and other groups had to be postponed month after month. So, with the Shire in lockdown for most of the time, little progress was made in 2021 on our 'wish list' of improvements. Now though we are making progress across the board, but it has been difficult as so many businesses and organisations have had so many changes of personnel our contacts have had to be re-established.

We have recently been able to use the Senior Citizen's facility which has greatly improved our ability to expand our programs especially the Bluegrass music group and singing groups. I am looking forward to seeing these programs grow as more people interact within our community.

The "beautifying Somerville" and bike trail projects collaborating with the Somerville/Tyabb Rotary Club have been really slowed down with the previous lockdowns but hopefully it will gain momentum again soon.

We were lucky to receive a Federal grant to plant trees for the Queen's Jubilee program and I look forward to watching the changes through the back windows as well the ongoing achievements of the gardening group who really enhance the SCH homely feeling.

We hope everyone stays safe and I am proud to be a part of the Somerville Community House and the vital role it plays in bringing together local people, community organisations, government, businesses and philanthropic organisations to achieve and support community-strengthening ideas that sit behind the whole Community House philosophy.

Manager's Report 2022

It is my pleasure to present my sixth report as Manager of the Somerville Community House for 2022. The end of 2021 saw us released from lockdowns and curfews at the end of October and we reopened our doors to groups on 1 November with density restrictions. Even though we were faced with the looming uncertainty of the pandemic we continued to focus on keeping people connected and safe through regular online emails, book and yarn pickups as well as distanced walking groups, outside morning teas and garden activities to help maintain sanity. We also supported an inhouse Psychologist who was able to continue to see grateful clients face to face by following strict Covid Safety requirements.



As we continue to navigate our way out of the Covid-19 pandemic we adapt and respond to the many challenges to help our community feel safe. Most of our community are vaccinated however, it will take some time to return to a new normal at the Somerville Community House. The nursing staff continue to wear masks and ask a series of health questions before receiving clients to try and reduce the spread of viral infections.

The MPS conducted an energy audit on the Annie Sage Community Centre early in the year which led to the installation of seven Solar Panels on the roof to reduce electricity costs. We purchased new air filters to place in all the meeting rooms and the office to improve air quality and continue to provide hand sanitiser and face masks to anyone who enters and asks. With our need to reduce density requirements so too did our need to use the under-utilised Somerville Seniors' Hall for our ever-expanding monthly Bluegrass Music group. We continue to work with the Seniors and the Mornington Peninsula Shire to find a way to share this important facility and promote more community participation. We now have a regular singing group and a group of young adults learning how to cook basic meals, with many more exciting developments moving forward.

Time spent collaborating with the 12 other Community House managers across the Mornington Peninsula led to new branding and logo. We continue to liaise and support each other in a variety of ways through email, online meetings and the sharing of knowledge and resources. This year we celebrated Neighbourhood House week by sharing resources provided by the MPS to weave hundreds of stars supporting the Billion Star Project which promotes prevention of all forms of violence. Displays of stars adorn our Centre providing a sense of comfort to our many visitors.

Our program continues to expand and include new interests such as Floral Arranging, Photography, Mah Jong, the Card Game 500, a Ukulele class and we continue to support amateur musicians and provide a 'safe space' for them to share their love of music to the broader community. Last year we were fortunate to be able to host a Christmas lunch with 70 participants and be entertained by the Southern Sounds Chorus.

Our Knitting and Crocheting groups have continued to produce beautiful hand-crafted items for many charities including hundreds of toys for the Somerville CFA, beanies for the Hastings

Seamans' Mission and more. Our Somerville Stitches group sew facemasks, quilts and toys for a variety of charities, hospitals and schools. With leadership from Lyn Elton-Baker and work by this talented group, a new patchwork quilt hangs proudly in our centre.

I am very pleased that we were able to secure \$10,000 to commemorate Her Majesty's Platinum Jubilee, expand on the global tree canopy and will be able to plant a variety of native and heritage fruiting trees in our backyard over the next 13 months. We held a special Commemorative Event this September to plant the first tree and unveil a dedicated plaque, with a wonderful show of support and attendance from all sectors of our community.



1. STATEMENT OF ACCOUNTING POLICIES

The accounting policies adopted by the society follow the accounting standards issued by the Australian Accounting Bodies. Except where noted, these policies have been consistently applied.
